Fluoride ion can reduce serum calcium levels possibly causing fatal hypocalcemia. Material is extremely destructive to tissue of the mucous membranes and upper respiratory tract, eyes, and skin. Cough, Shortness of breath, Headache, Nausea Decomposition of the substance with tissue moisture. Under given conditions, contact with nitrites or nitric acid can lead to the formation of nitrosamines, which have shown themselves to be carcinogenic in animal experiments. The following applies to aliphatic amines in general: irritations after contact with eyes and skin. Mucosal irritations, coughing, and dyspnoea after inhalation. Other dangerous properties can not be excluded. Handle in accordance with good industrial hygiene and safety practice.
