Carbon oxides Nitrogen oxides (NO_x) Hydrogen chloride gas Combustible. Vapors are heavier than air and may spread along floors. Forms explosive mixtures with air on intense heating. Development of hazardous combustion gases or vapours possible in the event of fire.
